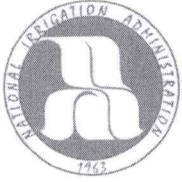

1. Business Matters:

Ma'am Nancy A. Poliran presented project Lower Sibuguey I RIS Extension Project Package 3 CY 2016 Remaining Works, and read and explained the MC 40 & MC 67, with subjects; Administrative Actions on Contracts with Negative Slippages and Guidelines in the Implementation of the 3-Strike Policy in Procurement for Contract in Infrastructure Works and Goods and Consulting Services, respectively.
