3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from National Irrigation Administration – Zamboanga Sibugay Irrigation Management Office and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M.

5. A complete set of Bidding Documents may be acquired by interested Bidders on February 12, 2024 – March 4, 2024 at 5:00 P.M. from the given address and website(s) below National Irrigation Administration – Zamboanga Sibugay Irrigation Management Office, DA- RFOIX Research Division Compound Sanito, Ipil, Zamboanga Sibugay notices.ps-philgeps.gov.ph, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos (Php 500.00). One The Procuring Entity shall allow the bidder to present its proof of payment for the fees will be presented in person, by facsimile, or through electronic means.

The National Irrigation Administration – Zamboanga Sibugay Irrigation Management Office will hold a Pre-Bid Conference on February 20, 2024 at 10:00 AM at National Irrigation Administration – DA- RFOIX Research Division Compound Sanito, Ipil, Zamboanga Sibugay and/or through video conferencing or webcasting via Google Meet, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below on or before March 5, 2024 at 9:00 AM. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on March 5, 2024 at 9:00 AM at the given address below National Irrigation Administration – Zamboanga Sibugay Irrigation Management Office, DA- RFOIX Research Division Compound Sanito, Ipil, Zamboanga Sibugay and/or via www.region9.nia.gov.ph, Google Meet. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The National Irrigation Administration – Zamboanga Sibugay Irrigation Management Office reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
