Bidders should have completed, within Two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from National Irrigation Administration – Zamboanga Sibugay Irrigation Management Office and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M.

5. A complete set of Bidding Documents may be acquired by interested Bidders on December 13, 2023 – January 3, 2024 before 9:00 A.M. from the given address and website(s) below National Irrigation Administration – Zamboanga Sibugay Irrigation Management Office, DA- RFOIX Research Division Compound Sanito, Ipil, Zamboanga Sibugay notices.ps-philgeps.gov.ph, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00). One The Procuring Entity shall allow the bidder to present its proof of payment for the fees will be presented in person, by facsimile, or through electronic means.

However, the interested Bidder can purchase the Bidding Documents only upon presentation of an Original Copy of Sworn Affidavit of Site Inspection, and an Original Copy of a Certificate of Site Inspection signed by the NIA authorized personnel or the Irrigators Association President certifying that the Bidder has actually inspected the Project Site (prescribe forms can be availed from this office). Photocopy is not acceptable. Such Affidavit/s and Certificate/s must be submitted for verification to the BAC Secretariat.

The National Irrigation Administration – Zamboanga Sibugay Irrigation Management Office will hold a Pre-Bid Conference on December 21, 2023 at 9:00AM at National Irrigation Administration – DA- RFOIX Research Division Compound Sanito, Ipil, Zamboanga Sibugay and/or through video conferencing or webcasting via Google Meet, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below on or before January 3, 2024 at 9:00 AM. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
