The National Irrigation Administration – Zamboanga del Sur Irrigation Management Office, through the GAA SIP CY 2022 intends to apply the sum of Php1,700,934.00 being the ABC to payments under the contract for NIAZDSIMO-NILO SIP -CY2023-010(GOODS). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The National Irrigation Administration – Zamboanga del Sur Irrigation Administration Office now invites bids for the above Procurement Project. Delivery of the Goods is required by Forty-Five (45) Calendar Days. Bidders should have completed, within Two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from National Irrigation Administration – Zamboanga del Sur Irrigation Management Office and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
