- Engr. Rex L. Armentia, Acting Manager of ZAMBASULTA RSO, read the contents of the bidding documents, wherein the contract has the following details:
 - a. Approved Budget of the Contract (ABC) is ₱ 5,145,207.95.
 - b. Required experience (50% of ABC) is **₱ 2,572,603.98**.
 - c. Project Duration is **168 calendar days**.

VII.BIDDING MATTERS

- Reading of MC No. 40, s. 2017 and MC No. 67, s. 2016.
- Prospective bidders were advised to submit proposals within the Approved Budget for the Contract.
- The bidders were informed to only use GPPB standard/prescribed forms in submitting their Bid-proposals. To re-orient and further familiarize them, forms were presented and discussed to wit:
 - 1. List of Equipment, Owned or Leased and/ or under Purchase Agreements, pledged to the Proposed Contract. Bidders were reminded that matrix form should be accomplished thoroughly, and registration numbers must be updated accordingly. Hence, for items that are not applicable should be filled with "N/A" otherwise indicate appropriate remarks. Forms with incomplete data/misrepresentation of facts may constitute the disqualification of the bidders. Also, bidders were reminded to avoid using equipment already pledged to other contracts.
 - 2. Qualification of Key Personnel Proposed to be Assigned to the Contract. Contractors/bidders key personnel assigned to on-going projects with NIA must not be recast/pledged again as key personnel for this bidding. The BAC will prioritize contractors/company which employs materials quality engineer.
 - **3. Key Personnel Biodata.** Form must be accomplished and signed with the concerned person. Licenses must be up to date.
 - 4. List of all on-going Government and Private Construction Contracts including Contracts awarded and not yet awarded. Data declared in the form must be with a legal basis and accurate. The BAC will be reviewing the bidder's background and any misrepresentation of data may constitute disqualification of their bid.
 - **5. Statement of Bidders' Single Largest Completed Contract (SLCC)**. Supporting documents to be attached must be complied accordingly.
 - 6. Documents Comprising the Bid: Eligibility and Technical Components (Clause 12, ITB of Public Bidding Documents)
 - a. Eligibility Documents
 - **Class "A" documents**
 - PhilGEPS Certificate of Registration (Platinum Membership)
 - Statement of all ongoing government and private contracts
 - Statement of SLCC
 - Notice of Award and/or Notice to Proceed
 - Project Owner's Certificate of Final Acceptance or the Constructors Performance Evaluation System (CPES) Final Rating, which must be at least satisfactory. (In the event of contracts with the private sector, an equivalent document shall be submitted.)
 - Valid Special PCAB license in case of joint ventures
 - Net Financial Contracting Capacity (NFCC) computation (Must be supported by Audited Financial Statement duly received by the BIR)

- b. Technical Documents
 - Bid Security
 - Bank draft/guarantee or Irrevocable letter of credit; or Surety Bond
 - Bid Securing Declaration (Cause 18.1, ITB of PBD)

- List of contractor's personnel (with complete qualification and experience data, and not already pledged to another contract)
- List of contractor's major equipment units (supported by proof of ownership, certification of availability of equipment from the equipment from the equipment lessor/vendor for the duration of the project)

- 7. Documents Comprising the Bid: Financial Component (Clause 13, ITB of Public Bidding Documents)
 - a. Financial Bid Form (Discounts offered must be provided with explanation)
 - Bid Price
 - Bill of quantities
 - b. Any other document stated in the Bid Data Sheet (BDS)
 - Detailed estimates (Labor rate should follow the updated Regional Wage Board)
 - Cash flow by quarter or payment schedule
- 8. Bid Validity (ITB Section 17)
- 9. Format and Signing of Bids (ITB Section 19)
- 10. Sealing and marking of Bids (ITB Section 20).
 - Documents must be softbound with tabbing according to checklist.
- 11. Deadline for Submission of Bids (ITB Section 21)
- 12. Late Bids (ITB Section 22)
- GPPB Standard Forms will be included upon purchase of Bid Documents.
 - Representative shall strictly bring Special Power of Attorney (SPA) from only (1) construction firm during Site Inspection.
- Other Reminders for Bidders:
 - 1. All documents duly must be signed.
 - 2. Submitting partial bids are not allowed.
 - 3. For withdrawing bids, a letter of withdrawal must be received by the BAC Secretariat before the scheduled start of bid opening.

The Opening of Bids is scheduled on **September 20, 2023,** at **9:00 AM** to be held at NIA Regional Office IX, Conference Room.
