The bids and award committee reminded the bidders the following:

a. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

b. The BAC Chairperson emphasis in the ITB that only the Authorized Managing Officer or Authorized Liaison Officer indicated in the submitted Company Profile or CRC is authorized to purchase and submit bidding documents. The use of a Special Power of Attorney (SPA) is prohibited, as stated in NIA Memorandum Circular No. 52, Series 2014, dated December 1, 2014. The bidder upon purchase of bid documents may present a valid ID or Certificate of Employment or any other documents that can prove they are an employee of their company.

c. The BAC Chairperson informed the interested bidder that before purchasing Bid Documents the bidder must present Original Certificate of Site Inspection, Sworn Affidavit of Site Inspection and Special Power of Attorney (SPA) for representative

per projects. Photocopy is not allowed.

d. The BAC inform the bidders that the deadline for purchasing bid documents is on

March 24, 2025 before 9:00 AM.

e. The BAC Chairperson reminded the bidders that they must attach only one contract similar to the project being bid, which should involve the same major categories of work and be valued at least 50% (fifty percent).

f. The BAC Chairperson reminded to deliver the materials on site based on the quantity, quality and specification stated in the bidding documents, for it will be the

basis for the inspection and acceptance of the items.

g. The BAC Chairperson reminded the delivery of the Goods shall be made by the Suppliers in accordance with the terms specified in Section VI (Schedule of Requirements).

h. The BAC Chairperson informed that NIA will provide a sample form & size of signage.

- i. The BAC Chairperson instructed the BAC Secretariat to prepare an addendum of the following Bidding Documents:
  - 1. PAYONGAN CIS the spelling of Boulder bidding into Boulder Bedding
  - 2. SVIS Repair-NIS P1 the spelling of Boulder bidding into Boulder Bedding
  - 3. SVIS Repair-NIS P2 the unit used in Concrete Vibrator instead of "set" correct into "unit"
  - **4. SVIS Repair-NIS P3** the unit used in Construction Gloves instead of "pieces" correct into "pairs" and for G.I PIPE & G.I Elbow additional **S-40** in item description.

The BAC read the checklist of Technical and Financial Documents and reminded everyone to follow it carefully to ensure their bid passes the evaluation.
