Sur upon payment of the applicable non-refundable fee in the amount of Php 1,000.00 for Lot 9.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Negotiated Procurement Documents not later than the submission of their bids.

3. The Procurement of the project will be conducted through Negotiated Procurement – Two Failed Biddings, an Alternative Mode of Procurement in accordance with Section 53.1 of the 2016 Revised Implementing Rules and Regulations of RA 9184.

- d) Original copy of Bid Security. If in the form of a Surety Bond, submit also a certification issued by the Insurance Commission or Original copy of Notarized Bid Securing Declaration. See Annex "C".
- e) Conformity with the Technical Specifications, which may include production/delivery schedule, manpower requirements, and/or after-sales/parts, if applicable. See Annex "D".
- f) Original duly signed Omnibus Sworn Statement (OSS) and if applicable, Original Notarized Secretary's Certificate in case of a corporation, partnership, or cooperative; or Original Special Power of Attorney of all members of the joint venture giving full power and authority to its officer to sign the OSS and do acts to represent the Bidder. - g) The prospective bidder's computation of Net Financial Contracting Capacity (NFCC) or A committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation.

- h) If applicable, a duly signed joint venture agreement (JVA) in case the joint venture is already in existence or duly notarized statements from all the potential joint venture partners stating that they will enter into and abide by the

provisions of the JVA in the instance that the bid is successful.
