- Prospective bidders were advised to submit proposals within the Approved Budget for the Contract.
- The bidders were informed to only use GPPB standard/prescribed forms in submitting their Bid-proposals. To re-orient and further familiarize them, forms were presented and discussed to wit:
  - 1. List of Equipment, Owned or Leased and/ or under Purchase Agreements, pledged to the Proposed Contract. Bidders were reminded that matrix form should be accomplished thoroughly, and registration numbers must be updated accordingly. Hence, for items that are not applicable should be filled with "N/A" otherwise indicate appropriate remarks. Forms with incomplete data/misrepresentation of facts may constitute the disqualification of the bidders. Also, bidders were reminded to avoid using equipment already pledged to other contracts.

- 2. Qualification of Key Personnel Proposed to be Assigned to the Contract. Contractors/bidders key personnel assigned to on-going projects with NIA & other agencies must not be recast/pledged again as key personnel for this bidding. One (1) key personnel should not hold dual function for the same project. The BAC will prioritize contractors/company which employs materials quality engineer.
- 3. Key Personnel Biodata. Form must be accomplished and signed with the concerned person. Licenses must be up to date.
- 4. List of all on-going Government and Private Construction Contracts including Contracts awarded and not yet awarded. Data declared in the form must be with a legal basis and accurate. The BAC will be reviewing the bidder's background, and any misrepresentation of data may constitute disqualification of their bid.
- 5. Statement of Bidders' Single Largest Completed Contract (SLCC). Supporting documents to be attached must be complied accordingly.
- 6. Documents Comprising the Bid: Eligibility and Technical Components (Clause 12, ITB of Public Bidding Documents)

  - Representative shall strictly bring Special Power of Attorney (SPA) from only (1) construction firm during Site Inspection.
- Other Reminders for Bidders:
  - 1. All documents duly must be signed.
  - 2. Submitting partial bids are not allowed.
  - 3. For withdrawing bids, a letter of withdrawal must be received by the BAC Secretariat before the scheduled start of bid opening.

#### a. OTHER MATTERS

- The Bids and Awards Committee (BAC) reminded the prospective bidders the following:

- Only the Authorized Managing Officer / Authorized Liasson Officer indicated in the submitted in the company profile /CRC shall be authorized to purchase and submit bidding documents. The use of Special Power of Attorney (SPA) is prohibited as per NIA Memorandum Circular No.52 s. 2024 dated December 1, 2014.
- Under ITB Clause 5.2. Contract similar to the project refers to contracts which have the same major categories of work which shall be completed for the past five years. Well drilling, supply/installation of Pump Irrigation Projects with Mechanical, Irrigation & Flood Control & Electrical Works.
- To be eligible to bid for the contract, bidders must have done a Single Largest Completed Contract (SLCC) containing a category of work which is the same as or similar to the major category of works and who's total SLCC cost is at least 50% of the Approved Budget Cost (ABC) to be bid.
- The above SLCC must be supported by a copy of the Contract, Certificate of Completion, and Owner's Certificate of Final Acceptance (1-year after the issuance of Certificate of Completion) issued by the project owner other than the contractor or a final rating of at least Satisfactory in the Constructors Performance Evaluation System (CPES). In case of contracts with private sector, an equivalent document shall be submitted.
- ITB Clause 7.1- Sub-contracting is not allowed.
- ITB Clause 10.3- A valid PCAB license is required, and in case of joint ventures, a valid special PCAB license and registration for the type and cost of the contract for this project.
- Key Personnel must meet the required minimum years of experience set in ITB Clause 10.4.
- The minimum major equipment requirement set in ITB Clause 10.5.
- ITB Clause 16-Bidder should submit one (1) copy of original document and two (2) copies, "Copy 1" & "Copy 2" of the Technical & Financial Documents. It should be soft bound and with ear-tabbing, (ring bounded and/or fastened documents will not be accepted.; and



ITB Clause 19.2-Partial bids are not allowed. For purposes of evaluation of the contract, the project should not be sub-divided into sub-lots.

The Opening of Bids is scheduled on July 24, 2024, at 9:00 AM (Wednesday) to be held at NIA Regional Office IX, Conference Room.
